Show Hours: This is a two day show and all vendors will be required to participate both days.

Show Dates: Saturday, September 25th, 2010 from 10:00am-6:00pm.
Sunday, September 26th, 2010 from 10:00am-5:00pm.

Booth Fees: Each booth space is 12'x14' and the cost is \$100.00 per regular space and \$125.00 per corner spot. Late fee is \$25.00. Electricity is \$15.00. All booths must be set up by 9:30am on Saturday and booth tear down will be at 5:00pm on Sunday. Make checks and money orders payable to the NC Spot Festival.
NOTE: Please indicate on your check what type of booth and extras that you are paying for.

Deadline: Application must be received no later than August 6th, 2010. It is to your advantage to **APPLY EARLY** as it increases your chances of becoming an exhibitor. You will be notified in writing no later than September 1st, 2010.

Liability Release Agreement

Spot Festival grounds where the booth is located, or while going to or departing from the same, and to indemnify and save harmless the N.C. Spot Festival and its representatives in interest from any liability and that the N.C. Spot Festival may suffer as the result of acts of negligence, fraud, or misconduct of any vendors agent or employees on or about the N.C. Spot Festival grounds.

I release the N.C. Spot Festival from any and all liability for loss or damage to property and merchandise used by the vendor in the operation of the concession due to theft, vandals, fire, storms, flood, and damage through any force of nature otherwise.

I further grant the N. C. Spot Festival permission to use any photographs, motion pictures, recordings, or any other record of my participation in the festival for any legitimate reasons.
